## Luncheon Meetings \$10.00/person

(Regular rate \$12.24 plus tax)

- Chef's choice meal (typically one entrée, one side and soup or salad)
- Chef's choice dessert
- Iced Tea, Water, Hot Tea and Coffee
- Use of the small banquet room or a section of the large room for (1) one hour
- Recommended minimum number of guests 15

## **Dinner Meetings** \$12.00/person

(Regular rate \$17.10 plus tax)

- Chef's choice meal (typically one entrée, two sides and soup or salad)
- Chef's choice dessert
- Iced Tea, Water, Hot Tea and Coffee
- Use of the small banquet room or a section of the large room for (2) two hours
- Recommended minimum number of guests 15

# **Dessert or Light Appetizer**

Meetings \$7.00/person

(Regular rate \$4.75 plus tax PLUS room rental of \$75/hour)

- Choice of assorted desserts or light appetizers
- Iced Tea, Water, Hot Tea and Coffee
- Use of the small banquet room or a section of the large room for (1) one hour
- Recommended minimum number of guests 20

#### MEETING GUIDELINES

- As there is no rental charge for use of the facility, all guests attending a meeting or event will be charged the full club/group rate. Upon request, most items can be packaged "to go" in place of eating at the meeting when necessary.
- Although there is normally a \$200.00 minimum for any event at Legacy, we have reduced this amount for clubs/groups that meet on a regular basis. Minimums are required to cover the costs of:
  - Set up of room / tables
  - A Chef to prepare meals approx. 3 to 4 hours
  - Banquet Staff approx. 4 or more hours
  - Food costs
  - Beverages
  - Utilities and other fixed costs
  - Storage of Club/Group supplies
  - General use of facility as we refer other clients from your groups date and times
- Recommended minimum number of guests will be reviewed if minimums are not met for more than two meetings.
- Legacy will include regular club/group meetings on its website and in other available forms of advertising as available. Includes: cable advertising, bulletin boards, trade show displays, etc.
- A minimal amount of club/group banners, etc. are permitted to be stored at Legacy for clubs/groups that call Legacy their home. We are not responsible for lost or stolen items.
